Key takeaways:

- - Auditory processing is not the same as hearing. Kids with excellent hearing can have central auditory processing disorder (CAPD).
- - A school hearing test does not assess for CAPD.
- - A school CAPD screener is not sufficient for ruling out CAPD.
- - CAPD evaluation should utilize a complete battery that looks at the entire system.
- - CAPD is often genetic and shared by parents and their kids.
- - CAPD symptoms overlap with ADHD, autism, sensory, and language disorders.
- - A person can have both autism and CAPD (one does not rule out the other).

- - A “quiet” environment may not feel quiet to a person with CAPD.
- - Most kids don’t outgrow CAPD — the struggles continue into adulthood.
- - Myth: “there’s nothing you can do about CAPD.” Treatment includes school-based accommodations, environmental modifications, sound-blocking headphones, FM system, therapies, and hearing aids.
- - Able Kids Foundation makes an individualized “filter” for its clients based on evaluation data. This filter helps clients mediate background noise.
- - The “average” student with CAPD “hears” only 60% of what is said. With the filter provided by Able Kids Foundation, this level of understanding improves to 80%!
